

**THE DISTRICT OF HUNTINGDONSHIRE
(OFF-STREET PARKING PLACES) ORDER 2011**

- Notice is hereby given that on 7th November 2011 Huntingdonshire District Council made an Order under Sections 32 and 35(1) and (3) of the Road Traffic Regulation Act 1984 and of Part IV of Schedule 9 to the Act and of all other existing legislation, to control the use of the parking places named in Schedule 1 to this Notice, which shows the classes of vehicles, the days of operation, the maximum period of waiting and the scale of charges for each parking place.
- The Order specifies the conditions under which the parking places may be used between the hours of 7.00 am and 6.00 pm on the days of operation set out in Schedule 1 to this Notice. Full details are contained in:
 - Pathfinder House, St Mary's Street, Huntingdon – during normal office hours;
 - The Town Hall, St Ives – during the Town Clerk's normal office hours;
 - St Neots Town Council Offices, The Priory Centre, St Neots – during the Town Clerk's normal office hours; and
 - Ramsey Library, Gt Whyte, Ramsey – during normal opening hours.
- In the case of the parking places described:
 - In column (a) of Schedule 2 to this Notice the Order provides for the issue of permits to the residents within designated areas of the Schedule exempting them from limitations of time and from any payment imposed under Schedule 1 of the Order.
 - The Order provides for the issue of user permits to users of the Priory Centre, St Neots authorised by St Neots Town Council exempting holders from limitations of time and from any payment imposed under Schedule 1 of the Order in respect of the Priory Car Park, St Neots
 - The Order provides for the issue of HDC permits authorised by the District Council exempting holders from limitations of time and from any payment imposed under Schedule 1 of the Order in respect of the car park designated on the permit
 - The Order provides for the issue of season parking permits to residents or employees of that town to use those car parks specifically listed in Schedule 3 to this Notice exempting them from limitations of time and from any payment imposed under Schedule 1 of the Order
 - The Order provides for the issue of season parking permits to visitors of Country parks to use those car parks specifically listed in Schedule 3 to this Notice exempting them from any payment imposed under Schedule 1 of the Order
 - The Order provides for any motorcycle which is parked within a marked parking bay which is indicated by markings on the surface of the parking place as for use by a motorcycle shall be exempt from any payment imposed under Schedule 1 of this Order but must not exceed the maximum time allowed for that parking place.
 - The Order provides for the driver of a vehicle which displays a disabled person's badge shall be exempt from any payment and exempt from any limitation of time imposed for those car parks listed under Schedule 1 of the Order except for the St Germain St (Disabled) and Chequers Ways (Disabled) Huntingdon
- Any person who wishes to question the validity of the Order or any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or of any instrument made thereunder has not been complied with in relation to the Order, may within six weeks from the date on which this Order was made apply to the High Court for this purpose.
