

# LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

## The Huntingdonshire District Council (Reorganisation of Community Governance) (Glatton & Conington Parish) Order 2025

Made 12 February 2026

Coming into force in accordance with article 1(2)

Huntingdonshire District Council (“the council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations on 17th December 2025:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by section 86 and 240(10) of the 2007 Act.

### Citation and commencement

1. (1) This Order may be cited as the Huntingdonshire District Council (Reorganisation of Community Governance) (Glatton & Conington Parishes) Order 2025 relating to the Parishes of Glatton and Conington.

(2) It shall come into force on 1st April 2026.

### Interpretation

2. In this Order

“district” means the district of Huntingdonshire

“map” means the map marked “Huntingdonshire District Council (Reorganisation of Community Governance) (Glatton & Conington Parishes) Order 2025” and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

**Alteration of parish areas**

- 3. Each area coloured and designated by a letter on the map and specified in column (1) of the Schedule shall cease to be part of the parish specified in relation to that area in columns (2) of the Schedule and shall become part of the parish specified in relation to that area in columns (3) of the Schedule.

**Electoral register**

- 4. The registration officer for the district shall make such arrangement of, or adaption of, the register of local government electors as may ne necessary for the purpose of, and in consequence of, this Order.

**Order date**

- 5. 1st April 2026 is the Order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008 but for all purposes connected with or preliminary to the said election the said Order shall come into operation upon such prior day as may be necessary to give effect hereto.

## **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order gives effect to recommendations made by Huntingdonshire District Council for the alteration of the area of the parish of Glatton and the alteration of the parish of Conington within the district of Huntingdonshire.

Article 3 provides for alterations to parish areas.

Article 4 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.

The maps defined in Article 3 show the alteration to parishes. They are available for inspection during normal working hours at the offices of Huntingdonshire District Council, Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN.
