### IMPORTANT NOTICE

PLEASE NOTE that the above hearing is a **PROVISIONAL LISTING** and has been listed with other cases on the above hearing date. This final list will be fixed on the working day before the hearing and will be dependent on settlements and adjournments. If a late adjournment would cause you difficulties e.g. special needs or witnesses travelling long distances, you must notify the court at least 14 days before the hearing date. Otherwise, you may assume that your case may be heard on the above date and prepare accordingly.

Some cases can be listed as block hearings which means there will be more than one case with the same start time. For those cases not heard at the specified time every effort will be made to hear them as soon as possible during that day. Should your case not be heard on the date specified it will be relisted on the first available date. Although rare, in some instances an adjourned case may be released to another Judge or possibly another court.

The court may need to change the location of the hearing, up to 90 miles from the original hearing venue, so that the case can continue on the specified day thereby avoiding the need to adjourn the case to a new future date.

Please note:

A) the case may be moved to a different hearing venue or stood out at short notice. HMCTS will contact you by 2 pm, the working day prior to the hearing if this is the case.

B) the case may not be called on for hearing at the time stated and there may be some delay.

The Court and HM Courts and Tribunal Service will not be responsible for any costs incurred subject to changes made in accordance with the policy at (A) and (B) above.

If the hearing is not required either because of settlement or you wish to apply to adjourn, you should contact the Court as soon as possible.

#### **Applications to adjourn / Change Hearing Type**

If you wish to adjourn a hearing and you have the written consent of the other party, and pay the relevant fee, this will be referred to a Judge to consider. If an adjournment is not agreed, you must make an application to the Court and pay the relevant fee and a hearing may be fixed to consider the request.

Parties wanting to change the hearing type, (i.e. from an in person hearing to CVP Video or telephone) must make a formal application and pay a fee, which will then be referred to a judge for consideration. This must be done at least 7 days before the hearing.

#### **Directions on Filing of Trial Bundles, if applicable**

PLEASE NOTE: The Court is NOT able to accept electronic bundles submitted via links that require an account to be set up or a password to access them. i.e. Egress.

Failure to comply with these directions may result in the matter being removed from the list without further warning.

- The parties should seek to agree an indexed, paginated electronic trial bundle and any indexed paginated electronic authorities' bundle; and
- One party (which shall be the Claimant in default of agreement otherwise) shall email the electronic bundle to the Court at [enquiries.peterborough.countycourt@justice.gov.uk](mailto:enquiries.peterborough.countycourt@justice.gov.uk) and the other parties no less than 3 days and no more than 7 days before the hearing date
- A hard copy bundle would be required for any trial listed as an attended 'in person' hearing. All trial bundles are to be filed at the County Court Peterborough at least 3 clear days before the trial date. Any hard copy bundles not taken away after a hearing will be destroyed.
